The minutes of the November 7th regular meeting were sent to the council for reading prior to the meeting. Motion by G Guenthner, second by Z Guenthner to approve the minutes of the November 7th regular meeting. Motion carried.

The November Financial statement was sent out to the council for reviewing prior to the meeting. After discussion a motion was made by G Guenthner, second by Anderson to approve the November Financial Statement. Motion carried. Motion by Heiberger, second by Anderson to approve Resolution 11-1212C – Contingency Transfer. All present voted aye. Motion carried.

The bills for the month of November were reviewed. After discussion a motion was made by G Guenthner, second by Heiberger to approve the November bills. Motion carried.

Vern Arens of Arens Engineering was here to set bid opening for the Bridgewater 2012 Main Street Sanitary Sewer Project. Final completion date would be August 10, 2012. Motion by Heiberger, seconded by Z Guenthner to set January 9th, 2012 at 7:30 pm for the bid opening for the Bridgewater 2012 Main Street Sanitary Sewer Project. Motion carried.

Attorney Mike Fink went over the updated animal control services contract with Sioux Falls Area Humane Society with the council. Motion by G Guenthner, seconded by Heiberger to accept and sign the Animal Control Services agreement with the Sioux Falls Area Humane Society. Motion carried.

At 7:15, no bids were received for the surplus tractor with sweeper attachment. Council decided to readdress this surplus tractor with sweeper attachment this spring.

Attorney Mike Fink & Ed Meyer discussed with the council the donation of "Sparky Park" to the city. Attorney Fink indicated that the liens related to the "Sparky Park" property appear to have been satisfied in approximately 2009. And since 22 years have passed since the tax proceedings related to the parcel, he advised the city that they could acquire the property by "Quit Claim Deed" as McCook County Abstract did perform a Title search in 2005 on this property. Paper work will be drawn up for the January meeting.

Council discussed with Attorney Fink and Sheriff Norris the enforcing of our ordinances. In particular, semi trucks and dog issues were addressed. Council decided to each look at the truck ordinances and bond schedule and bring to the next meeting their ideas on changes needing to be done. Attorney Fink will be here also.

Public Input:

• Sandi Tschetter asked about whether the city would have a place to park semi trucks. Council doesn't feel it's the city's problem to provide a place for semi trucks to park. It's their duty to find their own place to park especially in the winter when they may need to be plugged in.

Written maintenance report by Todd Letcher included:

- Cleaning up trees out at the city park
- Worked on Poplar down by 9th street

At 8:00 pm a motion was made by G Guenthner, seconded by Z Guenthner to recess the City Council and reconvene as Board of Adjustment. Motion carried. Luke and Dorothy Olson are requesting a Conditional Use Permit (#033) for agricultural activities – the management of poultry at their residential address of 331 N Minnesota Ave. After discussion, a motion was made by G Guenthner, seconded by Heiberger to grant a 60 day Conditional Use Permit subject to review in 60 days to see if there are any complaints. All present voted aye. Motion carried. Permit will be reviewed in 60 days. Motion by Z Guenthner, seconded by Heiberger to adjourn as Board of Adjustment at 8:05 pm. Motion carried.
