ORDINANCE NO.2016-1

AN ORDINANCE REVISING BRIDGEWATER MUNICIPAL ORDINANCES, SECTION 5.0104 - "EXCESSIVE NOISE, INCLUDING RADIOS, TELEVISION SETS, MUSICAL INSTRUMENTS, AND SUCH SIMILAR DEVICES PROHIBITED".

BE IT ORDAINED BY THE CITY OF BRIDGEWATER, MCCOOK COUNTY, SOUTH DAKOTA:

That Ordinance 5.0104 EXCESSIVE NOISE, INCLUDING RADIOS, TELEVISION SETS, MUSICAL INSTRUMENTS, AND SUCH SIMILAR DEVICES PROHIBITED shall be amended to read as follows:

~~5.0104 Excessive Noise, Including Radios, Television Sets, Musical Instruments, and Such Similar Devices Prohibited.~~ Using, operating, or permitting the use or operation of any radio receiving set, television set, musical instrument, drum, or other machine or device, ~~for the production or reproduction of sound~~ in such a manner as to be plainly audible at the property boundary of the source or plainly audible at fifty (50) feet from such device ~~when operated within a vehicle~~ anywhere within the limits of the City, is prohibited. A violation of this section is a misdemeanor.
