# Bridgewater City Council Regular Meeting Minutes January 6, 2020 7:00 pm

The City Council of the City of Bridgewater met in the Council Room for their regular meeting on Monday 1/6/2020. The meeting was called to order at 7:00 pm by President Travis Holthaus. Answering roll call were Bob Anderson, Tony Hofer, Travis Holthaus, Lacey Weber, Alicen Strombeck, and Mark Vondra. Others present: Finance Officer-Joan Julson, Maintenance-Todd Letcher, Roger Hofer, Jerry Paweltzki, Steve Sievers, Yvonne & Sage(son) Mendoza, and Mike Damm.

Pledge of Allegiance was recited.

The minutes of last month's meetings were sent to the council for reading prior to the meeting. Motion by Anderson, second by Vondra to approve the December 10<sup>th</sup> regular meeting minutes. All present voted aye. Motion carried.

The December Financial statement was sent out to the council for reviewing prior to the meeting. After discussion, a motion was made by Hofer, second by Weber to approve the December Financial Statement. All present voted age. Motion carried.

The bills for the month of December were reviewed. A motion was made by Weber, second by Strombeck to approve the December bills. All present voted aye. Motion carried.

Maintenance report by Letcher. He reported that he's been doing snow removal and also working on getting items ready for summer work. Weber asked how he does it for snow removal and cars parked along the streets. Whether he calls Sheriff Norris to ticket them or what is being done. Notice will be put in paper to remind people to make sure they are parked off the street in order to avoid a ticket and possible tow. He also reported that Anderson & him went up to check on the 1985 Caterpillar 130G Motor Grader w/hydraulics in Huron at the SD Federal Surplus. They both drove it. It has 245 hours on it, is in pretty good shape, and a lot of machine for that price. Motion by Anderson, second by Hofer to purchase the 1985 Caterpillar 130G Motor Grader w/hydraulics from SD Federal Surplus at a cost of \$16,000. All present voted aye. Motion carried. Council discussed declaring the old one surplus and putting the old one on some kind of auction. Anderson and Letcher will check out the auction sites in the area and their costs and bring to the next meeting.

At 7:15 it was brought up that no bids were received for the foosball table. It will be rescheduled for next month.

#### Public Input:

- Yvonne Mendoza came to inform the council about the rental condition of a home in Bridgewater that they just moved out of. Mike Damm also gave input on this home. Council discussed asking our attorney about what we could do as a city with any rental property that has questionable living conditions.
- Roger Hofer had a few comments on the storm sewer project. Vondra commented that if the
  farmland drainage wasn't draining thru the city, we wouldn't have half the drainage problems. The
  field ditching and going thru the berm by the park should never have been allowed. He's had
  water about up to his house due to all of this.
- Jerry Paweltzki addressed the housing in town, the keeping of the old Tribunes, and also the planting of new trees in town.

President Holthaus moved on as there being no other public input.

Storm Sewer Project: Vondra is still working with the landowner for a proposed retention pond but hasn't received any answer yet. More info for the February meeting.

Steve Sievers asked when the Lumberyard storm sewer was getting done. He's tired of waiting and it needs to be done. Letcher & Anderson will talk with CMC and if they're too busy we'll have to find someone else to do it.

Law Enforcement: December Law Enforcement report so noted.

Code Enforcement: Council received attorney information on nuisance issues on Poplar and Oak. Motion by Vondra, second by Hofer to sign the AT&T Request for Estoppel Certificate relating to the tower site. All present voted aye. Motion carried.

Motion by Hofer, second by Strombeck to sign the revised SDPAA Intergovernmental Contract. All present voted aye. Motion carried.

Motion by Weber, second by Anderson to set April 10<sup>th</sup> as our Election date. All present voted aye. Motion carried. Seats up this year: 1 yr – Mayor & Ward II & III Council seats (Vondra & Hofer) 2 yr - Ward I, II, III Council seats (Strombeck, Anderson, Weber)

Motion by Anderson, second by Vondra to pass Resolution #20-0106—Salary List. All present voted aye. Motion carried.
