2nd reading of Supplemental Appropriations Ord #A-114 was also done. Motion by Hofer, second by Strombeck to pass Supplemental Appropriations Ord #A-114. All present voted aye. Motion carried. The bills for the month of November were reviewed. A motion was made by Anderson, second by Strombeck to approve the November bills. All voted age. Motion carried.

Maintenance Report by Letcher. 1) working on plow truck 2) pumping down at lagoon for winter 3) talked about some type of screen for the storm drains to prevent gutter debris from clogging the system.

Public Input: Genny Houston informed the council of an incident that occurred at her home. McCook Co Sheriff Dept had already been contacted. No other comments. Vice President Vondra moved on.

Storm Sewer Project: Motion by Strombeck, second by Hofer to have Council President Holthaus sign the updated Certificate of Project Completion for the Storm Sewer Improvements Project. All present voted aye. Motion carried. It was noted that the updated copy includes a principal forgiveness amount of \$260,000.00 or 14.8%. The SRF loan amount is for

\$1,760,000.00 with a \$260,000 principal forgiveness amount and a deobligated amount of \$1.00 leaving a loan repayment amount of \$1,499,999.00.

Government Buildings/Municipal Liquor Store: Motion by Hofer, second by Strombeck to allow the Christmas decorations in Sparky Park be stored in the 312 N Main city building. All present voted aye. Motion carried.

Vondra also reported that he has a door & frame to put into the Municipal Liquor Store by the men's restroom to help with the draft coming from the back door that was damaged in an attempted break-in this fall. We are still waiting on the new rear door from Interstate Glass to replace the damaged rear entrance door. This door, due to its size, had to be specially made & is coming out of California.

Ambulance: Jim Julson reported that the power load has gotten installed into the ambulance. The ambulance is still in dire need of EMT's. Motion by Hofer, second by Strombeck to allow 2 EMT's to go to the SD Ambulance Assoc. Annual Conference in Ft Pierre in February. All present voted aye. Motion carried.

Law Enforcement: November report so noted.

Parks & Recreation: Motion by Strombeck, second by Anderson to allow North Central Service Inc. to use the ball park area, by the cell tower, for a staging area of the Golden West fiber optic install this summer. All present voted aye. Motion carried.

Planning & Zoning: No building permits

Motion by Anderson, seconded by Hofer to set aside in reserves - \$500 to sewer repair & maintenance, \$5000 for ambulance and \$5000 for firetruck. All voted aye. Motion carried.

Employee reviews were tabled for January for full council.

Thank you from the Jack Vondra family was also noted.

There being no further business, a motion was made by Hofer, second by Anderson to adjourn. Motion carried. Time 8:02 pm.
