Bridgewater City Council Regular Meeting Minutes January 8, 2024 7:00 pm

The City Council of the City of Bridgewater met in the Council Room for their regular meeting on Monday 01/08/2024. The meeting was called to order at 7:00 pm by President Travis Holthaus. Answering roll call were Bob Anderson, Luke Burger, Travis Holthaus, Tony Hofer, Alicen Strombeck, and Mark Vondra. Others present: Finance Officer-Joan Julson, Maintenance-Todd Letcher, Sheriff Mark Norris, and Jim Julson.

Pledge of Allegiance was recited.

The minutes of last month's meetings were sent to the council for reading prior to the meeting. Motion by Burger, second by Vondra to approve the December 6th regular meeting minutes. All voted aye. Motion carried.

The December Financial statement was sent out to the council for reviewing prior to the meeting. After discussion, a motion was made by Anderson, second by Hofer to approve the December Financial Statement. All voted age. Motion carried.

The bills for the month of December were reviewed. A motion was made by Anderson, second by Vondra to approve the December bills for payment. All voted aye. Motion carried.

Maintenance Report by Letcher: 1) his health update 2) snow removal and the amount of cars, pkups, trailers not removed from the sides of the streets for snow removal. Ticketing & towing for this was discussed with Sheriff Norris.

Public Input: No one here with input, President Holthaus moved on.

Storm Sewer: Trent Bruce-DGR (by phone due to the weather) went over the Storm Sewer Project Phase 2 progress. Talked about the boring under the highway and dealing with the railroad. Motion by Vondra, second by Burger to approve and sign Application 1 for \$718,632.00 for payment. All voted aye. Motion carried. This will be sent in for reimbursement.

Ambulance: Motion by Strombeck, second by Vondra to sign Mitchel ALS Intercept Agreement. All present voted aye. Motion carried. Discussed shortage of help.

Law Enforcement: December Sherriff report noted. Sheriff Norris was here to answer any questions. Motion by Anderson, second by Hofer to set election date for April 9th. All voted aye. Motion carried. Seats up this year: 2 yr – Mayor, Ward I, II, III & 1 yr Ward III Council seats (Strombeck, Anderson, & Burger)

Motion by Vondra, second by Burger to designate The Special as the official newspaper for 2024. All present voted aye. Motion carried.

Motion by Strombeck, second by Hofer to designate Rivers Edge Bank as the official depository for 2024. Motion carried.

Motion by Hofer, second by Strombeck to continue the Bridgewater Development monthly donation of \$500. All present voted aye. Motion carried.

Motion by Anderson, second by Burger to sign the 2024 Agreement with Eich Law for city attorney. All present voted ave. Motion carried.

Motion by Burger, seconded by Vondra to set aside in reserves - \$500 to sewer repair & maintenance, \$5000 for ambulance and \$5000 for firetruck retroactive back to Dec 2023. All voted aye. Motion carried.

Motion by Vondra, second by Hofer to go into Executive Session for SDCL 1-25-2.4 for employee reviews & negotiations. All voted aye. Motion carried. Time 8:05 pm. President Holthaus declared executive session over at 8:23 pm.

Motion by Vondra, second by Strombeck to give a \$1.00 per hour increase for Julson and Letcher effective 1/1/24. All voted aye. Motion carried. On the recommendation of the auditors to clarify the payment of Julson's Medicare. A motion was also made by Vondra, second by Burger that the City of Bridgewater does provide group health coverage for their eligible employees and Medicare eligible employees are given the option to sign up for that group health coverage. The eligible employees can choose to waive the group health coverage and the City of Bridgewater can reimburse the eligible

employees for Medicare Part B, Medicare Part D, and Medicare Supplement Insurance Premiums. All voted aye. Motion carried.

Motion by Hofer, second by Vondra to hire Matt Anderson as temporary part time/as needed for \$25 per hour. All voted aye with Anderson abstaining. Motion carried.

Motion by Anderson, second by Hofer to hire Jerico Shape as temporary part time/as needed for \$17 per hour effective 1/1/24. All voted aye. Motion carried.

Motion by Burger, second by Hofer to pass Resolution #24-0108 – 2024 Salary List. All present voted aye. Motion carried.
